- 1. Members may fill up the Postal Ballot Form and return the Form duly completed to The Scrutinizer, Agro Tech Foods Limited, Karvy Fintech Private Limited at Karvy Selenium Tower B, Plot 31-32, Gachibowli, Financial District, Nanakramguda, Hyderabad –500032, so as to reach on or before 17.00 Hrs (IST) on Wednesday, 20 March 2019. The Ballot Form received thereafter will strictly be treated as if not received.
- 2. The Company will not be responsible if the envelope containing the Postal Ballot Form is lost in transit.
- 3. Consent must be accorded by placing a tick mark in the column 'I/We assent to the Resolution' or dissent must be accorded by placing a tick mark in the column 'I/We dissent to the Resolution'. Form bearing tick mark on both the columns will be treated as invalid.
- 4. The vote of the Members will be considered as invalid on the following grounds:
  - a. If a form other than Postal Ballot Form issued by the Company is used.
  - b. If the Postal Ballot Form is not signed by or on behalf of the Member.
  - c. If the Members signature does not tally with the specimen signature with the Company.
  - d. If the Member has marked his/her/its vote both for 'Assent' and also 'Dissent' to the Resolution in such manner that the aggregate Equity Shares voted for 'Assent' and 'Dissent' exceeds the total number of shares held.
  - e. If the Member has made any amendment to the Resolution or imposed any condition while exercising his vote.
  - f. If the Postal Ballot Form is incomplete or incorrectly filled.

g. If the Postal Ballot Form is received torn or defaced or mutilated such that it is difficult for the Scrutinizer to identify either the Member or the number of votes, or whether the votes are for 'Assent' or 'Dissent', or if the signature could not be verified, or any one or more of the above grounds.

h. If the voting rights of a Member are frozen by any competent authority.

- 6. The right of voting by Ballot Form shall not be exercised by a proxy.
